The United States Coast Guard is a branch of the U.S. Armed Forces under the U.S. Department of Homeland Security. The Coast Guard is the principle Federal agency responsible for maritime safety, security, and environmental stewardship in U.S., ports, and inland waterways.

The U.S. Coast Guard has about 40,000 active-duty personnel, 7,000 reservists. 8,500 full-time civilian employees and 31,000 auxiliary members. The United States Coast Guard Auxiliary (CGAUX) is the civilian uniformed volunteer of the United States Coast Guard established by Congress in 1939.

The CGAUX purpose is to augment the U.S. Coast Guard, though it is non-military and has no law enforcement authority. The CGAUX's primary mission is to promote boating safety upon the inland and coastal waters of the United States of America.

The CGAUX operates in.

- Safety and Security Patrols
- Search and Rescue
- Mass Casualty or Disasters
- Pollution Response and Patrols
- Homeland Security
- Recreational Boating Safety Education, Information and Resources
- Commercial Fishing and Vessel Exams and Recreational Vessel Safety Checks
- Platform for Boarding Parties
- Recruit for all service in the Coast Guard.

Membership is open to all men and women who are citizens of the U.S. and is seventeen years of age or older. There are no specific physical standards that must be met to enroll in the Auxiliary. Auxiliarists decide on the level of participation they would like to do. To be certified in an operational discipline, Auxiliarists must demonstrate their ability, mobility, and endurance to satisfactorily complete performance-based training and qualification tasks. There is an annual dues under \$100.00 a year. Certain missions may require you to purchase the appropriate uniform.

The CGAUX has recently started a youth program with the Boy Scouts of America Sea Scouts for young men and women ages 14 years through 20. Any Sea Scout may choose to become a full member of the U.S. Coast Guard Auxiliary.
